Warranty Statement; *Add description of product provided & to be warranted*

Project Reference: TK *Add*. **Year Installed:** *Add*.

Franklin Hodge Industries, (The Company), will make good, by repair or, at its option, the supply of a replacement, defects which under proper use appear in the Goods and arise solely from faulty design, materials or factory workmanship, for a period of one year (twelve calendar months), from the date of dispatch of tank materials from our factory, or the date of our practical completion of the tank(s) on site and warrants *Add customer name* of the above address (The Customer), provided always that:-

- (a) Any claim for alleged break of warranty must be presented to The Company within thirty days after the alleged defect was first noticed, or the defect and all warranties will assume to have been waived by The Customer.
- (b) The water storage tanks supplied, are employed for normal use and service, that is excluding among other things; the exposure of the tank and internal liners to harmful chemicals, temperatures, mechanical abuse by machinery, equipment or people, or excessive pressure or stress from any source. And that paints and coatings and applied finishes are excluded from the warranty.
- (c) The Goods are properly inspected & maintained, at intervals not exceeding 18 months, in accordance with the Company's laid down procedures by adequately trained and skilled operatives, including adherence to the recommended cleaning & chlorination procedures.
- (d) The defective part has been returned should the Company so require. The Company shall refund the cost of carriage on any parts so returned, and repaired or new parts will be supplied free of charge by any method of transport at the Company's sole discretion.

- (e) The Company shall owe no liability whatsoever to the Customer in respect of any direct or indirect loss including without prejudice to the generality of the foregoing loss of profit or of contracts or for any loss or damage of any kind whatsoever and whether caused by the Company's breach of contract, tort, statutory duty or otherwise howsoever and irrespective of the cause or extent thereof save for damages for death or personal injury.
- (f) The Customer agrees to arrange its own insurance cover for any losses, which may be suffered by it arising out of any delay in the supply of the Goods or any defects therein.
- (g) The terms of this warranty document are to be covered by and interpreted under English Law.
